RE: Ann Gotlib Investigation

The complainant, called to report she had information concerning the Gotlib case. I called her on September 13, 1989, at 1425 hours. Ms. told me she saw Ann Gotlib with a man in Bashford Manor Mall around 1245 hours on June 1, 1983, or May 31, 1983. She was unsure on the date, but knew it was a Tuesday. Gotlib left the mall around 1300 hours on her bicycle. She said the man had a dark, thin, sunken face.

When Ann Gotlib was in the mall, she saw Ann wait in front of Pass Pets. When she was approached by the man and he said "are you ready to go," Ann said yes and they went to Target. She saw Ann almost break away from the man, but he slapped her and he said she would get it later.

Ms. said she repeated this on the third day of the investigation, when she recognized the photograph on television. Each time she called someone would answer, put her on hold, and never get back with her. So she never reported it again.

Recently she talked with information. Ms. speculated speculated 's brother-in-law was the man who took Ann.

The interview concluded at 1445 hours.
